# **DNR NIGHTTIME ELECTROFISHING**

DPW Director Sanchez was notified that the MDNR will be conducting nighttime electrofishing on Lake Orion this week. The fishing is not expected to extend beyond midnight each night. Electrofishing uses direct current electricity that affects the movements of nearby fish so that they swim toward the electric current and can be caught or stunned. It is a common method used to sample fish populations. When performed correctly, electrofishing results in no permanent harm to the fish, with fish returning to their natural mobility state in as little as two minutes after being caught.

# **POLICE CHIEF APPOINTMENT**

Interim Police Chief Stanfield has declined the offer for the permanent police chief position. I will be starting the process for the recruitment of a permanent chief. Chief Stanfield has done an outstanding job of providing continuity, stability, and leadership for the department during this transition period, and we appreciate his dedication and hard work.
